*****A. INTRODUCTION*****

1. Definitions: All capitalized terms used in these Official Rules shall have the meaning ascribed to them in Section C entitled “Definitions” at the end of these Official Rules, or as otherwise defined herein.

2. Eligibility: Only United States residents who are eighteen (18) years of age or older, and the age of majority in their states of residence if the age of majority is greater than eighteen (18), as of the first day of the Entry Period are eligible to participate in the Sweepstakes. Entries are limited to individuals only; commercial enterprises and business entities are not eligible.

Sponsor and each employee, officer, director, agent and representative of Sponsor, and their respective immediate family (spouse, parents, siblings, children, step-parents, step-siblings, and step-children, regardless of where they live) and same household members, as well as Sponsor’s respective parents, subsidiaries, affiliates, franchise company, all of its respective advertising,
